# **Request to Prevent Disclosure of Directory Information**

The items listed under *Directory Information* may be released in accordance with the Family Educational Rights and Privacy Act of 1974 (FERPA), as amended. Under the provisions of FERPA, as amended, you have the right to withhold the disclosure of *Directory Information*.

Please consider carefully the consequences of any decision to withhold *Directory Information*. Should you decide to inform this institution not to release *Directory Information*, any future request for such information from non-istitutional persons or organizations will be refused. For example, the university would be unable to verify degree, major or enrollment for possible employment, credit card applications, insurance purposes, mortgage information, apartment leases, etc.

Should you decide to withhold *Directory Information*, you may authorize at a later date on a transaction-by-transaction basis the release of directory or non-directory information (for example, the release of a transcript for employment purposes, or candidacy for Queen Alalah) or you may cancel withhold directory. See below for instructions.

Note to students about to graduate: The withhold directory flag will remain on your records after graduation if you have requested that the information be withheld; therefore, we will not be able to verify your degree to potential employers. (See below for removal of Withhold Directory Information designation.) Cowley will honor your request to withhold the information listed below but cannot assume responsibility to contact you for subsequent permission to release that information. Regardless of the effect upon you, Cowley assumes no liability for honoring your request for information to be withheld.

#### Directory Information includes the following:

- o Name
- o Addresses (Current and Permanent)
- o Telephone number
- o Date and place of birth
- o Major field of study
- o Participation in officially recognized activities and sports
- o Height and weight of members of athletic teams
- o Dates of attendance
- o Degrees awards received
- o Awards received
- o Most recent previous educational institution attended
- o Photograph
- o Email addresses; and
- o Enrollment status (full-time, half-time, less than half time)

This form should be submitted to the Registrar's Office on or before the first two weeks of each semester or session. Forms will be accepted after these deadlines, but we cannot be responsible for the release of *Directory Information prior to receiving the Directory Information Withhold request in the Registrar's Office.* 

## **Withhold Directory Information**
