# II. Legislative Agenda & Sumner County Sales Tax

- Jessica Lucas, Government Affairs Liaison, presented the timeline and history of the Sumner County sales tax approval and campus development.
- The College will continue to receive Sumner County sales tax dollars through March 2027 with final payout in May of 2027.
- The Board discussed the potential of a new campaign to renew the sales tax for an additional 10 years as well as ideas for future campus development/expansion.
- Zach Cooper, Director of Sumner Campus, presented ideas for use of the additional land the College already owns that does not include additional construction with the following priorities:
  - o Utilize the land
  - Promote the College
  - Add educational value

- HB2105 July 1 (d) Each institution shall post and make publicly available on such institutions website all training materials used for students, faculty and staff on all matters of nondiscrimination, diversity, equity, inclusion, race, ethnicity, sex or bias and all of such institution's polices and guidance on such matters.
- Title IX August 1 date but recent Kansas injunction
- FLSA July 1 change in exempt threshold, with another change in January
- Gainful Employment/Financial Value Transparency- US Dept. of Education two measures: the debt-to-earnings measure and the earnings premium measure.
