

AP 250 – ADMISSIONS PROCEDURE

I. Procedure Scope and Purpose

This procedure outlines the process for admitting students to Cowley College. It applies to all prospective students, including degree-seeking, non-degree-seeking, high school, and international applicants. The procedure ensures that admissions decisions support student success and align with institutional and regulatory standards.

II. Definitions

New Student: An individual who has graduated from high school or earned a GED and is enrolling at Cowley College for the first time to pursue a degree or certificate.

Returning Student: A former Cowley College student who stopped out and is re-enrolling.

Transfer Student: A student who has previously attended another accredited college or university and is enrolling at Cowley College to continue their education.

Guest Student/Non-Degree Seeking Student: A student who is enrolled at another institution or is not pursuing a degree or certificate at Cowley College. Enrollment is limited to a maximum of twelve (12) credit hours under this classification.

High School Student (Concurrent Enrollment): A student currently enrolled in high school who is also taking college-level courses at Cowley College.

International Student: A student who is a foreign national temporarily residing in the United States to pursue a specific course of study at Cowley College, typically under an F-1 or M-1 visa.

III. Procedure

A. Regular Admissions

Students who are considered a regular applicant include New Students, Returning Students, Transfer Students, Guest Students and Non-Degree Seeking Students. The completion of an application is required for admissions. International guest students must provide a Letter of Permission from their home institution. Students work with the registrar or their advisor to change their classification.

B. Current High School Student Admissions Requirements

Cowley College welcomes high school students who wish to earn college credit while still in high school. To be admitted as a dual-enrolled student, you must meet the following requirements and complete all necessary steps.

1. Complete and submit a Dual Enrollment – High School Application.

2. Enrollment is open to high school sophomores, juniors, and seniors. Ninth-grade students may also be eligible if they are classified as educationally gifted and have a current Individualized Education Program (IEP).
3. Students must satisfy the minimum grade point average (GPA) and assessment requirements as outlined in the college's policy, AP 462 – Assessment and Placement.
4. Complete a Dual Enrollment Permission form, which includes signed permission from their high school principal, counselor and parent/guardian.

C. International Student Admissions Requirements

Cowley College welcomes and accepts for admission students from around the world that are able to meet certain academic, language, financial requirements, and U.S. Citizenship and Immigration Services (USCIS) requirements.

An international student (new or transfer) must successfully complete all steps for Admissions to Cowley College, including:

1. Complete an International Student Application for Admissions.
2. Pay applicable International Fee.
3. Provide Transcripts. Non-English transcripts must be evaluated. (In-Cred recommended)
4. Demonstrate English Proficiency
 - TOEFL: iBT = 60; PBT = 500; CBT = 173
 - TSE = 4 or higher
 - IELTS = 5 or higher
 - Duolingo = 85 or higher
 - Completion of the senior year from an accredited high school within the US., with a 2.0 or higher cumulative GPA average for all coursework.
5. Submit a Cowley College Affidavit of Sponsorship.

International students who score near the English Proficiency requirements may appeal to a committee convened by the VPAA or designee that consists of representatives from academics, athletics, and student services.
